



How to Prepare for Your Stay

Woof Lodge resort strives to provide a safe and positive experience for our guests. We pride ourselves on providing loving and high quality care.

Health and Safety Requirements

All dogs must meet the following health requirements to ensure the safety and health of all our guests. Copies of the veterinarian records, including expiration dates, must be provided during registration, or sent over prior to boarding. Dogs without proper health documents will be refused both day care and boarding.

- **Rabies** – The Rabies Certificate and veterinarian proof of vaccine must be provided. Dogs over 3 months of age must have a rabies vaccination.
- **DHLPP/DHPP** – Distemper, Hepatitis, Parainfluenza, and Parvovirus vaccinations must be current and kept up to date. Puppies must have completed their third round of shots.
- **Bordetella (Kennel Cough)** - Must be administered at least 7 days prior to check-in. For boarding it must be updated every 11 months.
- **Fecal Test** – All dogs must have a fecal flotation test by a vet within 30 days prior to boarding for the first time and every 6 months after. The results must be negative for all parasites and bacterial infections. If any parasites or infections are found, your dog must be treated and retested with negative results.
- **Contagious Diseases** – At the time of arrival, dogs must be free of illness or disease that could potentially be harmful to other dogs. Dogs must not have been treated for any communicable disease in the past 14 days.
- **Flea & Tick program** – We recommend that all dogs be on a preventative flea and tick program. If your dog is found to be flea or tick infested, a treatment will be applied, and you will be charged \$25 plus the cost of medication.
- **Spay/Neuter** – All dogs age six months and older must be spayed or neutered.
- **Temperament test** – Before your dog attends day care, a temperament test is conducted to ensure your dog is not dog, food, or toy aggressive and to ensure your dog gets placed into the appropriate play group. At this time, your dog must meet all of our health requirements.

Dogs boarded overnight do not need a temperament test prior to boarding.

Reservations, Deposits and Payments

Reservations and Deposits – Give Woof Lodge a call to discuss your boarding needs and to make sure that dates are available. A deposit of \$50 is required to hold your reservation (Reservations between May 15th and Sept 15th require a 50% deposit of estimated cost). The deposit will be applied to your cost of boarding. Reservations are subject to a cancellation fee of your deposit. Fees are waived if cancelled 7 day prior to your scheduled check in date.

After making your reservation, complete the application and sign the agreement and release. Mail or email forms along with your security deposit to Woof Lodge within 5 business days.

Your reservation is not confirmed until your application, signed agreement, and deposit are received.

Payment – Woof Lodge accepts cash, personal check, Visa and Mastercard. Payment is required for the total number of days at time of check-in for boarding. Any additional charges will be collected when your dog is picked up. There is a \$35 fee for returned checks.

The rates are from the date of check in to 12 noon the following day regardless of your arrival time. Any dog picked up after noon will be charged \$5 per hour until checked out from lodging.

Identification and leashes – All dogs must arrive on a leash (no retractable leashes are permitted) and wear a collar with an identification tag. No choke, martingale, or prong collars are permitted.

Food – Owners must provide ample food for your dog's stay. Food should be packaged in meal portions in zip lock bags. All food must be clearly marked with your dog's name and your last name.

Bedding and bowls – Cot-style bedding and blankets are provided for your dog's comfort. For sanitary reasons, personal bedding and blankets from home are not accepted.

Toys and Chews – Dogs are permitted to have a rubber or latex toy or chew in their room. This should be restricted to a toy or chew that your dog can safely have unsupervised. Please limit your chews and toys to 2 items. No stuffed or furry toys are permitted without prior approval.

Administration of medication – Medications and supplements will be given at no additional cost while your dog is being boarded. All medications must have the correct dose in a vial. Be sure to mark medications with your dog's name and last name. Each time you check in you must complete a medication form.

Woof Lodge reserves the right to refuse any dog that does not meet our requirements.

Agreement and Release

1. By agreeing to use the services and facility of Woof Lodge LLC, I/we, undersigned owner(s) / caregiver(s), hereby release, waive and discharge Woof Lodge LLC owners, staff or volunteers from all liability for any and all loss or damage, and any resulting claim or damage, on account of injury, loss, damage, infestation, or disease to my/our dog(s), even injury resulting in death, whether caused by the negligence of Woof Lodge LLC, its owners, staff, or volunteers or otherwise while my/our dog(s) are under the care of Woof Lodge LLC.
2. I/We agree to indemnify Woof Lodge LLC , its owners, staff and volunteers for any loss, liability, damage or cost they may incur due to my/our presence or the presence of my/our dog(s) in or upon Woof Lodge LLC premises.
3. I/We hereby assume full responsibility for any harm caused by my/our dog(s) while in or on the premises and while my/dog(s) is/are under the care of Woof Lodge LLC. I/We further agree to indemnify Woof Lodge LLC, its owners, staff and volunteers for any loss, liability, damage, or costs they may incur due to any harm caused by my/our dog(s).
4. I/We expressly agree to this release, waiver and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the commonwealth of Pennsylvania, and that if any portion of thereof is held valid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
5. I/We further understand and agree that in admitting my/our dog(s) to Woof Lodge LLC, the owners of Woof Lodge LLC have relied on my/our representation that my/our dog(s) is/are in good health and has/have not harmed or shown aggression to threatening behavior toward person or any other dog(s).
6. I/We further understand and agree that any injury or illness that develops with my/our dog(s) will be treated as deemed best by Woof Lodge LLC, including treatment by a Veterinarian, and that I/We assume full financial responsibility for any and all expenses involved, even if such expenses were later found to be unnecessary, Furthermore, should my/our dog(s) pass away during my/our absence, I/We direct that a Veterinarian maybe called to safe keep my/our dog(s) until our arrival.
7. I/We understand that payment for boarding and all other services must be paid in full on the day of check-in.
8. I/We certify that I/We have read and understand the Agreement and Release and agree to accept all the terms and conditions and statements of this agreement.
